Resolution No. R2026-13 City Manager Contract Agreement (Mayor and Commission)

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPOINTING DARVIN WILLIAMS TO SERVE AS THE NEXT CITY MANAGER FOR THE CITY OF NORTH MIAMI BEACH; APPROVING THE EMPLOYMENT AGREEMENT BETWEEN DARVIN WILLIAMS AND THE CITY OF NORTH MIAMI BEACH ATTACHED AS EXHIBIT "A"; AUTHORIZING THE MAYOR OR DESIGNEE TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SCRIVENER ERRORS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

City Attorney Joseph Geller provided an explanation of the resolution and discussed the proposed employment contract agreement between Darvin Williams and the City of North Miami Beach.

Norman Powell appeared before the Mayor and Commission to represent Darvin Williams and discussed the proposed employment contract agreement and expressed that Darvin Williams preferred to receive a car allowance instead of a city vehicle and requested a base salary of \$285,000.00.

Mayor Joseph read a statement regarding the selection of Darvin Williams as City Manager.

The Mayor and Commission discussed the proposed employment contract agreement.

Darvin Williams appeared before the Mayor and Commission and discussed his time as City Manager of the City of Opa-locka.

The Mayor and Commission continued to discuss the proposed employment contract agreement.

Motion to approve the employment contract agreement to include a car allowance in the amount of \$1,000 and remove language regarding getting gas at the city fueling station made by Commissioner Fleurimond, seconded by Commissioner Su.

Motion to approve the employment contract agreement to include a base salary of \$260,000.00 made by Commissioner Fleurimond, seconded by Commissioner Jean.

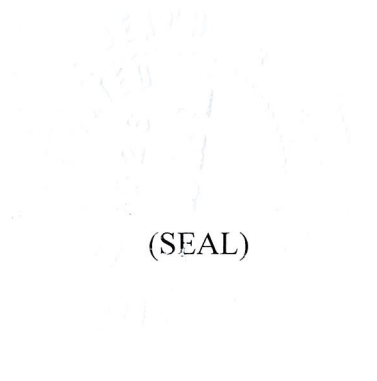
