This request includes, but is not limited to, the following records:

- Text messages or SMS communications
- Internal memoranda
- Reports
- Correspondence
- Meeting notes or summaries
- Draft documents and attachments
- Electronic communications of any kind
- Any other documents or records referencing the above-listed names

This request includes all correspondence or communications of any nature, including communications sent, received, forwarded, drafted, or stored by any city official, employee, contractor, consultant, or representative of the City.

Such communications include, but are not limited to, emails, text messages, instant messages, letters, memoranda, notes, attachments, draft documents, and communications sent through electronic messaging platforms including but not limited to WhatsApp, Signal, or similar applications.

This request also includes records maintained on city-issued devices as well as personal devices, personal email accounts, or any other electronic systems used to conduct official city business, including communications between elected officials, city employees, contractors, consultants, and any third parties communicating with the City.

Please conduct a reasonable and diligent search of all records systems, including but not limited to email servers, electronic communications systems, mobile devices, and files maintained by city officials and employees that may contain responsive records.
