



FINAL JUDGMENT LINDA JOSEPH -NOEL ONLY

IT IS ADJUDGED THAT Plaintiff, ARVON FUNDING, LLC, aao Gordon Food Service, whose address is PO Box 1434, Grand Rapids, MI 49501, recover from the Defendant, LINDA JOSEPH -NOEL a/k/a Linda Joseph a/k/a Linda Marie Joseph, whose address is 275 NW 157th Street, Miami, Florida 33169, the sum of \$14,999.00, pre-judgment interest in the sum, of \$580.81, reasonable attorneys fees are reserved as to amount only as entitlement is vested by Section 68.065, Florida Statute and the Contract, and \$310 (filing fees and issuance of summons) / \$90 (service of process) as costs, for a total sum of \$15,979.81, for which let execution issue forthwith.
