

**FINAL JUDGMENT LINDA JOSEPH –NOEL ONLY**

IT IS ADJUDGED THAT Plaintiff, ARVON FUNDING, LLC, aao Gordon Food Service, whose address is PO Box 1434, Grand Rapids, MI 49501, recover from the Defendant, LINDA JOSEPH –NOEL a/k/a Linda Joseph a/k/a Linda Marie Joseph, whose address is 275 NW 157<sup>th</sup> Street, Miami, Florida 33169, the sum of \$14,999.00, pre-judgment interest in the sum, of \$580.81, reasonable attorneys fees are reserved as to amount only as entitlement is vested by Section 68.065, Florida Statute and the Contract, and \$310 (filing fees and issuance of summons) / \$90 (service of process) as costs, for a total sum of \$15,979.81, for which let execution issue forthwith. Judgment shall bear interest at the legal rate, which is currently 4.75%, until paid in full. Jurisdiction is retained to enforce this judgment and to enter post-judgment relief.

IT IS FURTHER ORDERED AND ADJUDGED THAT the judgment debtor(s) shall complete under oath Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and serve it on the judgment creditor's attorney, Roniel Rodriguez IV, Esquire, 20533 Biscayne Blvd., 1243, Aventura, Florida 33180, Facsimile No.: 1(305) 359-5196, within 45 days from the date of this final judgment, unless the final judgment is satisfied or post-judgment discovery is stayed. Jurisdiction of this case is retained to enter further orders that are proper to compel the judgment debtors to complete form 1.977, including all required attachments, and serve it on the judgment creditor's attorney.
