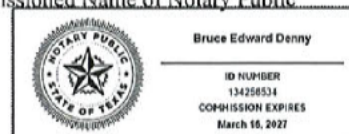

I, Carolina Matamoros, submit the following statement based upon my personal knowledge and records in my possession.

1. Employment Background

I am employed by the City of North Miami Beach as a part-time Constituent Aide to the Mayor. Since the commencement of my employment in January 2025, I have performed my duties under a remote work arrangement approved by the Mayor and City Administration. When necessary for meetings, trainings, or scheduled events, I report in person.

In February 2026, I met with Mr. Williams at his request for an introductory meeting. During that meeting, he advised that he was aware of my employment with another municipality and asked questions regarding my work schedule and the hours associated with both positions. I disclosed the requested information regarding my employment and work schedule. After meeting, Mr. Williams confirmed in writing that my remote work arrangement would continue until further notice.

2. Email Chain Involving Commissioner Fortuna Smukler

On May 27, 2026, Commissioner Fortuna Smukler emailed me regarding the Miami-Dade County League of Cities Gala and requested information concerning the Mayor's attendance.

After receiving direction from the Mayor, I relayed information regarding the disposition of his ticket. Following that communication, Commissioner Smukler removed the outside recipient from the email chain and copied City Manager Williams. Less than one hour later, City Manager Williams sent me a separate email directing that I copy him on all correspondence and referencing prior discussions regarding that requirement. Prior to that communication, I had not received a written directive requiring that I copy the City Manager on all correspondence.

3. Filing for Elective Office

On June 3, 2026, I filed as a candidate for elected office in the City of North Miami.

4. Change in Remote Work Arrangement

On June 6, 2026, City Manager Williams informed me that my previously approved remote work arrangement would be terminated effective June 19, 2026, and that I would be required to report to City offices beginning June 22, 2026.

The stated reasons for this decision included operational needs, training requirements, and coordination of legislative support personnel. Prior to this directive, my remote work arrangement had been approved and remained in effect.

5. Outside Employment Disclosure Directive

Also on June 6, 2026, City Manager Williams directed me to complete an outside employment disclosure form and submit it to Human Resources by June 11, 2026. In his correspondence, Mr. Williams stated that Human Resources did not have an outside employment disclosure form on file regarding my employment with another municipality and advised that I appeared not to be in compliance with applicable requirements.

This directive was issued despite the fact that Mr. Williams had previously discussed my outside employment with me during our February 2026 meeting and had requested information regarding that employment at that time.

I responded that I did not currently have active outside employment. Mr. Williams responded that the disclosure requirement applied regardless of active work status and further asserted that I appeared to be in violation of applicable policies.

6. Reference to Leave of Absence

During the June 6, 2026 correspondence regarding outside employment, Mr. Williams specifically referenced my leave of absence from my employment with another municipality.

That leave of absence was directly related to my candidacy for elected office. The reference to my leave status occurred after I filed as a candidate and in the context of employment that had already been discussed between Mr. Williams and me several months earlier.

7. Change in Tone and Escalation Following Candidacy

Based upon my personal observations and the attached correspondence, the tone and nature of communications directed toward me changed after I filed as a candidate for elected office.

Prior to my candidacy, Mr. Williams had acknowledged my outside employment, met with me regarding my work arrangements, and approved the continuation of my remote work arrangement.

Following my filing as a candidate, multiple directives and employment-related actions occurred within a short period of time, including:

- A directive requiring submission of an outside employment disclosure form;
- Assertions that I appeared to be out of compliance with applicable policies;
- References to my leave of absence associated with my candidacy; and
- Termination of my previously approved remote work arrangement.

In addition, the tone of written communications became increasingly admonishing and accusatory. After I asked whether the Mayor was aware of the changes to my work arrangement because my duties involved supporting the Mayor's office, Mr. Williams advised that I was "in need of training," stated that it was inappropriate for me to question him regarding conversations with elected officials, and instructed me to "govern yourself accordingly."

I do not know the reasons for these actions. However, I believe the timing, sequence, and nature of these directives and personnel-related decisions following my filing for elected office are relevant facts for the Commission's review.

8. Additional Information Regarding Related Parties

I subsequently learned that Commissioner Fortuna Smukler serves as a director of The Estime-Irvin Foundation, Inc., a nonprofit organization associated with Mary Estime-Irvin, who is my opponent in the election for North Miami City Council District 3.

I provide this information because Commissioner Smukler was involved in communications that preceded some of the events described above. I do not have personal knowledge that this relationship influenced any personnel decisions, but I believe the relationship may be relevant to the Commission's review.

9. Request for Review

I request that the Miami-Dade Commission on Ethics and Public Trust review whether the timing and sequence of the actions described above implicate:

- Section 2-11.1, Miami-Dade County Conflict of Interest and Code of Ethics Ordinance, including misuse of official position; and/or
- Section 2-11.1.1, Political Campaign Activities Ordinance, including whether governmental authority, personnel actions, or administrative decisions were exercised or taken in connection with my candidacy for elected office.

This statement is based upon my personal knowledge and the supporting documents attached.

Dear Ms. Matamoros,

As you are aware, under City policy, the City Manager has sole authority to approve remote work or work-from-home arrangements for City employees.

On February 25, 2026, I provided you with written approval to continue your existing remote work arrangement as an exception to the City's in-person attendance policy restated in a memo from my office through the Human Resources Department on February 2026. See email string below and memo attached. At that time, the arrangement was approved based on operational considerations and administrative needs.

Since that approval, Administration has undertaken a comprehensive effort to strengthen legislative support operations and enhance coordination among employees assigned to legislative and administrative support functions. As part of this effort, the City is implementing a robust training and professional development program for all legislative support personnel. In order to maximize the effectiveness of this initiative and ensure consistent service delivery, regular in-person participation will be required.

Accordingly, your previously approved remote work arrangement will conclude effective Friday, June 19, 2026. Beginning Monday, June 22, 2026, you will be expected to report to your assigned work location during regular business hours and perform your duties in accordance with the City's established attendance requirements.

This decision is not disciplinary in nature and does not affect your position, compensation, benefits, or job responsibilities. Rather, it is being made to support operational efficiency, ensure uniform enforcement of City policies, facilitate employee training and collaboration, and maintain the availability of legislative support personnel during regular business hours.
