Re: Statutory notice of false and defamatory publications concerning Linda Joseph Noel; demand for full and fair correction, apology, retraction, removal of protected address information, and preservation of evidence

Dear Ms. Kienzle:

1. Statutory Notice and Parties

I am Linda Joseph Noel, also publicly known as Linda Joseph. This letter provides written notice under section 770.01, Florida Statutes, identifying publications on VotersOpinion.com and the statements I allege are false and defamatory. It is directed to you individually as the named author and operator of VotersOpinion.com and to the publication itself.

The statements accuse me of crimes, fraud, dishonesty, unlawful candidacy, false identity, antisemitism, support for Hamas, theft, and other serious misconduct. They have been published repeatedly during an active municipal election campaign and disseminated to voters and third parties. I contend that the cumulative damage to my reputation, safety, campaign, professional standing, and emotional well-being exceeds \$50,000, exclusive of interest, costs, and any additional damages recoverable by law. Damages continue to accrue.

This notice challenges verifiable factual assertions and fact-implying accusations. Insults and political rhetoric are identified only where they supply context, reinforce a false factual implication, demonstrate repetition, or bear on fault and damages; they are not automatically asserted as independently actionable.

Privacy limitation. The records supporting my position—including identity, family, residence, employment, safety, financial, medical, and domestic-violence-related information—are being preserved privately and are not enclosed with this notice. Nothing in this notice authorizes publication, redistribution, or further investigation or disclosure of protected personal information. Evidence will be produced only when legally appropriate and subject to available confidentiality, redaction, protective-order, and court-record protections.

2. Publications and Statements Requiring Correction

The following schedule specifies the challenged publications and statements. Quoted excerpts are deliberately limited to the words necessary to identify the challenged assertion. The full pages, images, comments, updates, and linked materials must be preserved.

1. North Miami Beach Carpetbagger 'Ada Charles,' a/k/a Linda Joseph, a/k/a Linda Noel, has some thoughts — April 18, 2026

Statements identified as false and defamatory: That I was 'not a bona fide resident,' was 'ineligible to run,' lied about my identity, and was not related to Ada Charles.

Basis for falsity: I maintain that I am Linda Joseph Noel; Ada Charles is my sister; I did not impersonate her; and my qualifying and residency records—including my lease, voter-address history, driver-license information, utility records, and City qualifying file—contradict the assertion that I fraudulently or unlawfully sought office. The full meeting recording and sign-in circumstances must be reviewed rather than a selected excerpt.

Correction demanded: State that I did not impersonate Ada Charles; accurately state our relationship; withdraw the categorical nonresidency and ineligibility accusations; and link to or describe the complete qualifying record.

2. Does Linda Joseph, a/k/a Linda Joseph Noel, EVER tell the truth? — April 19, 2026

Statements identified as false and defamatory: That I 'does not reside in North Miami Beach,' lied about my birthplace, and invented a Haitian identity for political support.

Basis for falsity: I identify as Haitian-born and Haitian American. A data field or secondary record is not a substitute for a certified birth record and does not establish that I fabricated my identity. My residency evidence and City qualifying materials contradict the categorical accusation that I did not reside in North Miami Beach.

Correction demanded: Withdraw the categorical claims that I fabricated my birthplace or Haitian identity and that I fraudulently claimed North Miami Beach residency; explain any source-record limitation or data-entry discrepancy.

3. Linda Joseph, a/k/a Linda Noel, a/k/a Linda Joseph Noel ... one woman clown show — May 8, 2026

Statements identified as false and defamatory: That I had been 'impersonating an elected official,' committed a third-degree felony, and was not a Director with the Fight for \$15 movement.

Basis for falsity: I deny impersonating an elected official and deny committing the alleged felony. No charging document, conviction, or judicial finding establishing that crime was identified. My employment records, organizational records, archived materials, and witnesses support my Fight for \$15 leadership history; absence from a Wikipedia page is not proof that I did not hold the role.

Correction demanded: Unequivocally retract the felony and criminal-impersonation accusations and correct the denial of my Fight for \$15 leadership history.

4. The sad tale of Deadbeat Linda Joseph Noel and her hapless ex-husband — May 22, 2026

Statements identified as false and defamatory: That I was a 'Deadbeat,' owned no properties, fraudulently ran for office, escaped responsibility, and caused the described financial and marital harm.

Basis for falsity: The publication combines selected docket entries, third-party obligations, assumptions, and insults to imply current unpaid wrongdoing and personal culpability. Any actionable assertion must be compared with the complete certified docket, party obligations, satisfactions, releases, ownership records, and final dispositions—not selected motions or allegations.

Correction demanded: Correct any inaccurate ownership, payment, judgment, or responsibility statement; distinguish allegations and motions from adjudicated facts; and remove false implications of current unpaid criminal or fraudulent conduct.

5. Linda Joseph ... is also a literal CRIMINAL! — June 3, 2026

Statements identified as false and defamatory: That I am a 'literal CRIMINAL' and committed 'outright theft' and plagiarism of municipal intellectual property.

Basis for falsity: The accusation presents criminality as fact. I am not aware of any criminal charge, conviction, ownership determination, copyright ruling, or municipal finding that my use of the referenced graphic constituted theft. Similarity or reuse does not by itself establish criminal theft, ownership, lack of permission, or unlawful copying.

Correction demanded: Retract the criminal and theft accusations and state that no identified charge, conviction, ownership ruling, or adjudication established a crime.

6. Like her political idols ... Linda Joseph is a Jew-hating communist! — June 24, 2026

Statements identified as false and defamatory: That I am 'Jew-hating,' aligned with pro-Hamas actors, and a 'clear and present danger' to North Miami Beach.

Basis for falsity: I unequivocally denounce antisemitism, racism, hatred, and support for Hamas. A photograph, friendship, shared event, or agreement with another person on Haitian-community advocacy does not establish adoption of all that person's alleged beliefs. My direct written denunciation was supplied to and later published by VotersOpinion.com.

Correction demanded: Publish prominently that I unequivocally denounce antisemitism and Hamas; retract the assertions that I hate Jewish people, support Hamas, or pose a danger because of those alleged beliefs.

7. Carpetbagging 'candidate' Linda Joseph is a huge fan of a Jew-hating, pro-Hamas communist — August 4, 2026

Statements identified as false and defamatory: That my association or photograph established approval of 'Jew-hating' or 'pro-Hamas' views.

Basis for falsity: I deny those beliefs and expressly repudiated antisemitism and Hamas. The publication continued to impose beliefs on me based on association rather than a statement or act by me adopting them.

Correction demanded: Retract the false fact-implying association and publish my repudiation with equal prominence.

8. Oops! She did it again! ... literally steals the city's intellectual property! — August 4, 2026

Statements identified as false and defamatory: That I 'committed the exact same crime' and 'committed grand theft again.'

Basis for falsity: These are explicit accusations of repeated criminal conduct. No criminal charge, conviction, copyright judgment, ownership ruling, or City finding was identified. The legal ownership, authorization, public dissemination, and reuse status of the materials must be established before accusing someone of grand theft.

Correction demanded: Retract every accusation that I committed a crime, theft, or grand theft and state that no identified adjudication or charge established those assertions.

9. Lyin' Linda ... she's at it again! (UPDATED 2X) — August 5, 2026

Statements identified as false and defamatory: That I lied about my identity, sister, residence, voting history, birthplace, and legal eligibility and was 'fraudulently running for office.'

Basis for falsity: The publication draws categorical conclusions from selected voter and property records while disregarding or disputing my lease, address change, residency evidence, relationship evidence, qualifying file, and explanations. Election participation at an earlier date does not by itself determine later legal residence or candidacy eligibility.

Correction demanded: Correct the identity, relationship, residence, birthplace, and candidacy assertions using the complete records; retract the accusation of fraudulent or illegal candidacy absent an official adjudication.

10. Linda Joseph has some thoughts. And so do we. — August 10, 2026

Statements identified as false and defamatory: That my first public statements were ‘pure, unadulterated lies,’ Ada Charles is not my sister, and my residence and birthplace explanations were false.

Basis for falsity: This article confirms actual receipt of my direct denial and unequivocal denunciation of antisemitism. I maintain that the relationship and categorical identity/residency accusations are false and contradicted by complete family, residency, and qualifying records.

Correction demanded: Preserve my full denunciation prominently; correct the family relationship and categorical residency, identity, and dishonesty accusations; and cease repeating claims contradicted by authenticated records.

3. Prior Notice, Knowledge, and Fault

I previously disputed statements made about me, communicated that material was false, and attempted to respond through the publication. The August 10 article confirms that VotersOpinion.com received my direct written response and denunciation of antisemitism.

I have previously asked that my residential address and residence-identifying information not be published because I am a survivor of domestic violence and have safety concerns. Any correspondence, apology, deletion, correction, or assurance relating to that request must be preserved.

- ▼ Continued publication after receipt of contrary records or direct denials, deliberate avoidance of readily available confirming records, reliance on incomplete screenshots or selected docket materials, refusal to publish corrective material, and alteration or deletion after notice may bear on knowledge, reckless disregard, damages, and preservation duties.

4. Requested Full and Fair Correction, Apology, and Retraction

1. Remove or correct each challenged factual statement and headline identified above.
2. Publish a full and fair correction, apology, and retraction in a location and format at least as conspicuous as the original publication, with links from the original URLs.
3. State that no identified criminal charge or conviction established felony impersonation, theft, grand theft, or other criminality by me arising from the described conduct.
4. State that I unequivocally denounce antisemitism and Hamas and retract claims that I hate Jewish people or support Hamas.
5. Correct the categorical assertions regarding my relationship to Ada Charles, birthplace, employment history, residence, and candidacy eligibility after reviewing the authenticated records.
6. Remove protected residential-address information, unit numbers, maps, photographs, vehicle information, and descriptions facilitating identification of my residence, and do not republish those details.

7. Disable comments that repeat actionable factual accusations after notice, or publish the correction alongside them.
8. Provide written confirmation identifying each correction, retraction, removal, and URL affected.

5. Preservation Demand

Litigation is reasonably anticipated. Preserve all electronically stored information and paper records concerning me, the challenged publications, VotersOpinion.com, and related communications from January 1, 2026 forward, including:

- WordPress posts, drafts, revisions, deleted material, media files, comments, moderation logs, backups, database exports, timestamps, IP logs, analytics, and access logs.
- Emails, text messages, direct messages, social-media messages, call records, notes, research files, source documents, screenshots, and recordings.
- Communications with current or former North Miami Beach officials, candidates, campaigns, political committees, consultants, donors, activists, organizations, commenters, and intermediaries concerning me or the publications.
- Records of compensation, reimbursement, donations, subscriptions, advertising, gifts, research assistance, in-kind support, or other benefits connected to the challenged coverage.
- Communications with Bluehost, Newfold Digital, domain registrars, content-delivery providers, security services, and backup vendors concerning the site or complaints about the publications.
- Documents reflecting corrections, apologies, retractions, deletions, takedown requests, prior disputes, and decisions to publish or republish after receiving contrary information.

6. Litigation and Pattern Context

The following information is included as notice and preservation context only. A filing, demand, or administrative complaint does not establish that its allegations were true, and no unrelated matter is represented here as an adjudication against you unless supported by a final order.

- Evan Ross v. Stephanie Kienzle, Miami-Dade Circuit Court, Case No. 2018-026788-CA-01: publicly indexed materials identify Kienzle as a defendant; the operative claims and disposition require confirmation from the official docket.
- Morales, Ryan, et al. v. Christensen, Adam, et al., Case No. 35-2024-CA-001535-AXXX-01: a public docket index identifies Kienzle among defendants and reports a motion-to-dismiss ruling; the official order and final disposition must control any characterization.
- Stephanie Kienzle, et al. v. HostMonster.com, et al., Miami-Dade Circuit Court, Case No. 2020-025180-CA-01: published and indexed materials indicate that Kienzle sued the host and Daniela Jean after a complaint concerning publication of Jean's address; the official docket must be obtained.
- Marline Monestime's June 23, 2026 statutory demand and the subsequent public correction are relevant to notice and correction practices; the demand must not be mislabeled as a filed lawsuit.

I have received reports of a recurring pattern of coverage directed at people of color, particularly women of color who seek or hold local public office. I am preserving this as a reported pattern

and investigation issue. Discriminatory motive is not asserted as adjudicated fact. Relevant comparative records include target selection, article volume, criminal labels, family and residence disclosures, treatment after denials, corrections, and communications with political actors. Preserve records necessary for that comparative review.

7. Response Deadline and Reservation of Rights

Section 770.01 requires service of written notice at least five days before suit. Section 770.02 addresses the timing and effect of a full and fair correction, apology, or retraction. I request a written response and all corrective action within ten days after service of this notice. Nothing in this request extends any limitations period or waives any claim, remedy, objection, or right.

If a sufficient correction and resolution are not achieved, I am prepared to pursue available relief in a court of competent jurisdiction, including compensatory damages exceeding \$50,000, allowable presumed and special damages, injunctive or declaratory relief where legally available, costs, and any other relief supported by law and evidence.
