Dear Sir or Madam,

Please consider this my public records request for any and all visitor badge issuance logs, building access records, or security clearance visitor entry data associated with a person by the name of Linda Joseph, a/k/a Linda Noel, a/k/a Linda Joseph Noel.

The reason I am making this request is that this individual is running for a seat on the North Miami Beach City Commission, and she has disseminated a lot of conflicting information, including where she actually resides as well as the country of her birth place. The voters of North Miami Beach have a right to know the truth about candidates so that they can make an informed decision in November.

Linda Joseph, a/k/a Linda Noel, a/k/a Linda Joseph Noel was born on October 4, 1972, and claims to presently reside at 17071 West Dixie Highway, Apt. 516, North Miami Beach, FL 33160, per the attached Voter Registration Receipt issued by the Miami-Dade County Supervisor of Elections. Prior to that February 5, 2026, Linda Joseph claimed to have resided at 2 East Drive, North Miami Beach, Florida 33162 since August 7, 2025 when she changed her address with the Supervisor of Elections, per the attached Voter Audit Report, also obtained via public records request from the Miami-Dade County Supervisor of Elections. She deliberately used a North Miami Beach address in order to run for office in that city, which requires a residency of one (1) year prior to the qualifying period. She obtained a North Miami Beach address exactly one (3) year and three (3) days in advance of such date, which is Monday August 10, 2026.

Prior to that date, her permanent address was (and we believe still is) 275 NW 157 Street, Miami, Florida 33169, which would most likely be the address she used if she visited the Pentagon, as she recently claims she has done in a [post](#) on her Facebook page on August 6, 2026, i.e.:

My education and professional career have taken me into the White House, the Pentagon, and rooms you could never enter. I have held the credentials and security clearances required to enter those spaces.

Therefore, please provide me with any and all information on Linda Joseph, a/k/a Linda Noel, a/k/a Linda Joseph Noel, DOB 10/05/72, evidencing that she has "the credentials and security clearances" required to enter the Pentagon.
