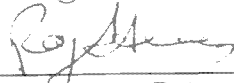
**MOTION TO HOLD LINDA JOSEPH IN CONTEMPT OF COURT FOR

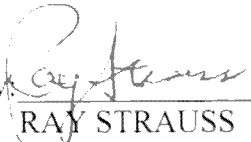
